Youthprise's mission is to reduce disparities with and for Minnesota youth in the areas of learning and leadership, economic opportunity, and health and safety.

In addition to meeting basic food needs through our Nutrition Hub, we work with community-based organizations and support them in accessing the federal and state food resources so that families in need can access free food in community settings they frequent. Youthprise takes a culturally informed wrap-around approach to advance intervention strategies that prevent the criminalization of youth, which can pose a threat to public safety. In 2019 Youthprise expanded our Nutrition Hub which served 65 sites, serving over 280K meals, and 5,500 youth in five counties. Additionally, we support a number of initiatives that seek to reduce youth homelessness, teen pregnancies, disparities in the juvenile

4b (Code: ) (Expenses \$ 2,220,725. including grants of \$ 1,433,547. ) (Revenue \$ 20,060. ) Learning and Leadership: Youthprise promotes the learning, leadership, and social-emotional development of youth. Programs and initiatives supported in this area expose youth to arts and culture, enrichment activities, technical assistance, and leadership opportunities including 55 convenings, five publications, and engaging 2,056 plus people. We seek to shift how programs interact with youth and support programs that engage youth in leadership and governance, a practice that we model at Youthprise. We embed young people across all areas of our organization, and we have 50% representation of youth on our Board of Directors, committees, and most are co-chaired by a young person.

4c (Code: ) (Expenses \$ 921,046. including grants of \$ 656,403. ) (Revenue \$ 0. ) Economic Opportunity: Youthprise creates opportunities for economic prosperity by supporting programs and initiatives that build workforce skills, promote youth entrepreneurship, and expose youth to career pathways. We work with a range of stakeholders across sectors to equip young people with the economic tools to thrive. In 2019, Youthprise awarded grants to connect young people with career pathways in high demand industries such as healthcare, information technology, automotive, and customer service in the Twin Cities and Greater Minnesota communities. Opportunity Reboot program served 1,449 youth, placed 634 youth in jobs, and provided support for 337 youth to retain employment.

In addition, each grantee agrees that it will not promote, support, or engage in terrorism of any kind, nor will it make sub-grants to any entity or individual that engages in these activities. Any unused portion grants, or amounts not used for charitable purposes, will be returned to Youthprise.

Installment payments may be withheld in the event of delays in completing the purposes of the grant and/or a breach by the grantee of any of the terms of the grant agreement or the grant conditions. The grantee shall maintain financial and other records that specifically show use of grant funds exclusively for the purposes of the grant. A separate bank account for the grant is not required, but it is necessary that a separate accounting of this grant be maintained. Grantees are also required to satisfy grant conditions based on progress toward completion of the deliverables described in the grant conditions.

Nongovernmental grantees have submitted to Youthprise a determination letter of tax exemption issued by the Internal Revenue Services that states

the grantee is tax exempt under Section 501(c)(3), and is not a private foundation as defined in Section 509(a) of the Code. The grantee further states that its determination letter is still valid and the organization's tax exempt status has not been revoked. The grantee is required to provide in writing to Youthprise within 10 days of receiving notice of any changes to its tax exempt status, including private foundation status under Section 509(a). In the event the grantee has failed to comply with the terms of the grant agreement or if its tax-exempt status is revoked by the Internal Revenue Service, the grantee, upon written notice from Youthprise, shall immediately return all unexpended grant funds to Youthprise and Youthprise may terminate the Agreement.
