1 Briefly describe the organization's mission: Youthprise is a nonprofit intermediary that invests in the future of Minnesota by investing in youth. Youthprise's mission is to increase equity with and for Minnesota's indigenous, low-income, and racially diverse youth.

Health and Safety: Youthprise supports programs and initiatives that promote the health and safety of young people. In addition to meeting basic food needs through our Nutrition Program, we work with community-based organizations to link healthy lifestyles with good nutrition. We take a holistic approach to health and safety and advance intervention strategies that prevent the criminalization of youth, which can pose a threat to public safety. In 2022, Youthprise served nearly 250,000 meals to young people ages 6 to 18 at 20 sites across 3 counties. Additionally, we support efforts that seek to reduce disparities in the juvenile justice system and contact between non-violent youth and law enforcement. Youthprise provided approximately \$1.1 million in individual support funds to young people

4b (Code:) (Expenses \$ 2,974,471. including grants of \$ 1,153,777.) (Revenue \$) Learning and Leadership: Youthprise promotes the learning, leadership, and social-emotional development of youth. Programs and initiatives supported in this area expose youth to arts and culture, enrichment activities, technical assistance, and youth leadership opportunities. We seek to shift how programs interact with youth and support programs that engage youth in leadership and governance, a practice that we model at Youthprise. We embed young people across all areas of our organization, and we have a goal of 50% representation of youth on our Board of Directors. In 2022 our Minnesota Afterschool Advance (MAA) program scaled up to help low-income students in 105 cities across Minnesota. MAA distributed 199 laptops for distance learning and helped 1,587 students access after-school activities via the MN tax

(Revenue \$) Economic Opportunity: Youthprise creates opportunities for economic prosperity by supporting programs and initiatives that build workforce skills, promote youth entrepreneurship, and expose youth to career pathways. We work with a range of stakeholders across sectors to equip young people with the economic tools to thrive. In 2022, Youthprise facilitated access to training and technical assistance for approximately 4,000 youth through our workforce development initiatives. Approximately 1,000 were received professional certifications or credentials, and 988 were placed in jobs.
